At its December meeting the Session will vote on whether or not to convenant to become a Matthew 25 church. What is that? It is a movement within the Presbyterian Church (USA), rooted in scripture (Matthew 25:31-46), which "calls on mid councils, congregations, and groups to live out the church's mission through bold and compassionate discipleship."

I have experience with this movement in my previous church and presbytery and have found it to be an incredibly

helpful tool in focusing a sense of mission. Who are we in today's world and what should we be doing?

There are three pillars in the Matthew 25 movement:

"Building congregational vitality by challenging congregations and their members to deepen and energize their faith and grow as joyful leaders and disciples actively engaged with their community, seeing new disciples engaged in ministry and longstanding believers develop in faith as the gospel of Jesus Christ is shared in word and deed.

"Dismantling structural racism by fearlessly applying our faith to advocate and break down the systems, practices, and thinking that underlie discrimination, bias, prejudice, and oppression of people of color.

"Eradicating systemic poverty by acting on our beliefs and working to change laws, policies, plans, and structures in our society that perpetuate economic exploitation of people who are poor."

What I have found liberating in this movement is the explicit linking of church vitality with an outward focus on "big ticket" items. The church is encouraged to dream big, to take a lead in helping to shape our environment in impactful ways—to build, in Dr. Martin Luther King Jr.'s words "the Beloved Community." Vitality is defined in passionate, faithful, and outward-focused mission, as opposed to merely church attendance or membership numbers.

In the face of growing secularization, progressive churches have often been tempted to feel irrelevant—and in feeling so, becoming so. We have felt powerless, paralyzed and have often flirted with a kind of low grade despair. We turn inward. We look for someone to blame. We look for magic bullets to turn back the clock to some imagined golden age. We grow small in our hopes and our faith.

Other churches have been tempted toward the idolatry of

Christian Nationalism, or the Prosperity Gospel. None of these responses are scriptural, faithful, or even especially helpful in addressing the reality of secularization and the decline in the mainline denominations.

The Matthew 25 movement calls us to a radical hope—to reclaim our agency returned to us by the victory over sin and death in Jesus' crucifixion and resurrection. It calls us out of the shadows of the tomb and into the streets and the communities that we have been called to serve.

In covenanting to become a Matthew 25 church, Market Square would be mostly ratifying what we already do—but we would also be gaining a valuable tool helping us to focus our mission and root it in scripture and Jesus' mission.

As we "seek first the Kingdom of God," I encourage us all to read **Matthew 25:31-46** again (and often) and visit the movement's web page: https://pcusa.org/matthew25.

Take A Deeper Dive!

This fall Market Square initiated a new Bible Study Class that includes discussion designed not only to take a deeper dive on Bible passages but also to help us build connections in our lives.

The class, which meets at 9:30 a.m. in the Youth Room (4th floor), allows us to connect scripture with our daily lived experience, connect with one another, and connect with God.

Led by Elders John Dame and Kevin Burrell, participants discuss what God is saying to us and how it relates to our lives and our world today. Scripture focus is the weekly lectionary, specifically the selected Old or New Testament passage that will be the focus of each Sunday's sermon, allowing us to both learn through discussion in class and also receive additional perspective from the pulpit.

For example, one of October's lectionary passages focused on Luke 18:9-14, which told the parable of the Pharisee and the Tax Collector and their prayers to God. Class discussion focused on different interpretations of the prayers each uttered and how each prayer said something about their self-awareness and the lessons that can teach us, while the sermon focused on the danger of judging others and the necessity for discernment in making those judgments, for example, judging and rightly condemning policies that ICE has adopted in detaining and confronting people while being cautious in judging individual ICE members, who may or may not agree with those policies.

All members are encouraged to join this time for fellowship and meaningful discussion by taking a deeper dive into what the Holy Spirit speaks to us through the written Word!

At Christmas, God came into our ordinary world in the form of a child, and still today, God is at work through the ordinary stuff of life, if we train our eyes to see. The book, *Advent in Plain Sight*, draws readers' attention to ten ordinary objects that appear in the biblical narratives of messianic prophesy and incarnation. Through focusing on these objects, we can see the near kingdom of heaven on earth and ponder what that divine proximity enables and asks us to do and be.

This year our church will use the seasons of Advent, Christmas, and Epiphany to facilitate conversation and connection to each other and the meaning of this time in the church year. The goal of this group study will be to focus on spiritual lessons and recognize how the seemingly ordinary can reveal the extraordinary presence of God in our lives.

From Refuge to Rejection: America's Moral Responsibility to Welcome the Stranger By Dr. Phuong N. Truong

When Mr. Ahmad and his family arrived in the United States in 2024, they came as refugees—fleeing Afghanistan in the aftermath of the Taliban's return to power. Like so many before them, they hoped for safety, dignity, and a chance to rebuild. They landed not just in a new country but in a new life, with nothing but courage and the clothes on their backs.

With the support of Jewish Family Services and later the International Services Center's Afghan Refugee Support Services, Mr. Ahmad began a relentless journey toward self-sufficiency. His story is one of perseverance: navigating new systems, learning English, attending job interviews with the help of interpreters, and eventually securing a forklift operator position. His wife, too, secured a job as a caregiver for his elderly parents. Slowly but surely, the Ahmad family was becoming part of the American fabric. This is just one story of hundreds of families our organization, International Service Center (ISC), works with every year.

Then the door slammed shut.

On January 27, 2025, the administration suspended the national Refugee Resettlement Program. Agencies were forced to terminate critical refugee programs overnight. Families were left adrift in a sea of uncertainty. As if that were not enough, President Trump has now declared that the Temporary Protected Status (TPS) program for 200,000 Afghans—and 16 other countries—will not be renewed. And what hovers over so many families we serve is the looming threat of deportation.

The administration's strategy is not subtle. Its end goal is not reform, but removal. There is no honest attempt to fix a "broken system," only a maximalist effort to purge the country of people who sought a better future. TPS, asylum claims, parole programs—these are being dismantled not because they failed, but because they succeeded in helping vulnerable people survive.

Now, those people—our neighbors—are being criminalized.

The International Service Center is still reeling from the abrupt suspension of government reimbursements; we have spent over \$300,000 out of our funds reserved for other important projects to continue providing refugee support services. And yet, amid this chaos, communities of conscience have stepped up. Most notably, the Market Square Presbyterian Church (MSPC) where the ISC has been operating from for half a century, has stood firm in its support, providing moral clarity and critical financial lifelines, including a \$30,000 donation from longtime members William and Jane Murray.

MSPC's recent "Operational Security" memo does not mince words: *The demonization of immigrants is immoral.* It outlines concrete legal and ethical strategies to resist unconstitutional raids, protect the dignity of their buildings as sanctuaries, and stand unwaveringly on the side of justice. Their moral compass points true north, guided by the ancient imperative: "I was a stranger, and you invited me in."

Some may say the issue is political. But when families are being ripped apart, when workers contributing to our economy face deportation, when churches prepare for federal agents to knock on their doors, this is not a policy debate. This is a moral emergency.

We must ask ourselves: What values do we uphold when we turn our backs on those fleeing wars, persecution, and tyranny?

The data is crystal clear. Studies from the Migration Policy Institute, Economic Policy Institute, and the Department of Health and Human Services all show that immigrants are not a burden. They are a boon. Immigrants contribute billions in tax revenue, bolster our aging workforce, and fill critical roles across industries. Their children will keep our schools, hospitals, and social security programs alive.

Yet, even with facts on their side, it is stories like Mr. Ahmad's that most powerfully remind us of what is at stake. America is not merely a set of policies. It is a set of promises. And those promises mean nothing if we do not keep them in the face of fear.

So let us raise our voices. Let us speak of compassion, not contempt. Let us call on Congress not only to restore funding, but to restore humanity. Let us reject the cruelty of mass deportation and instead embrace the courage of welcome.

Because what we do now—how we respond to that knock at the door—will define who we are as a nation.



MARKET SQUARE'S WORK WITH REFUGEES

Market Square Church started helping refugees in 2018. We continue to help the AlMeslehs of Syria today. In addition, the 2 brothers of patriarch Ayman AlMesleh have brought their families to Mechanicsburg, and we have helped them. In early 2022, metro Harrisburg started to see a large influx of Afghans due to the U.S. military pullout from Afghanistan. Market Square Church mobilized a volunteer bank of 25 individuals who wanted to help refugees. Since that time, we have helped and continue to help 7 Afghan families, the 3 Syrian families previously mentioned, and 1 Sudanese family.

Our help has included ESL teaching and tutoring, finding jobs, locating housing, transporting refugees to medical and dental appointments, registering youngsters in the school systems, obtaining bicycles, facilitating a car donation, obtaining and delivering furniture and household goods to the refugee homes, and related matters. It has kept us busy.

I have been asked if the International Service Center (ISC) located in our basement is still operational. The answer is "yes." 16 of the ISC staff were laid off recently due to shortage of funds. Today walking through the ISC area I see fewer employees. But on Friday, 11/7 our food pantry for refugees was in full operation with ample supplies of produce, canned and packaged products, fresh eggs, frozen Butterball turkeys and turkey breasts. Currently the ISC staff is helping Ayman AlMesleh get a good, full-time job. From what I see the ISC is alive and well.

There is a substantial army of volunteers in metro Harrisburg helping refugee families. These helpers come from churches and religious organizations. Case workers and staff from the ISC help and support the volunteers. The ISC is headed by an excellent Executive Director, Dr. Truong Phuong.

In the 4 years I've been involved with refugee work, I've found refugees to be resourceful, hardworking, optimistic people. They don't complain! They are thankful for our outpouring of help. I am grateful and thankful to be able to do this work with the full support of Market Square Church and all our wonderful volunteers!! Thank you!!!!

In November, Session's activities included:

Faith and Justice

- 1) Approved the launch of a free Street Medicine program a volunteer-based medical outreach effort providing essential healthcare directly to individuals who experience homelessness in and around Market Square Presbyterian Church. <u>Background:</u> When Rev. Stan met his new personal physician, Dr. Shenoy, for the first time and his doctor learned where he worked, Dr. Shenoy said that he knew of the church's work with the unhoused. He said that he was interested in doing a free medical clinic at the church. A trial run occurred during the November 16th Sunday community breakfast. The trial went really well. Eleven people were seen; two received antibiotics; others received prescriptions. To ensure building security, patients are escorted by Market Square volunteers to meet with Dr. Shenoy in Dave Volkman's office.
- 2) Approved the continuation of the Friday night takeout meal program for those who are hungry and increased the average cost per week to \$300 using funds from the James Jones Feed the Hungry Fund. <u>Background:</u> They are currently serving about 130-140 meals each week. This is the maximum number of meals that can be prepared and is well above the eighty meals a week that was originally planned. Costs have also risen in the past year.
- **3)** Approved the continuation of Ben Perez's employment as Coordinator of Homeless Services with funding to come from the Eleanor Allen Fund for the Homeless and/or other sources.
- 4) Approved Market Square's commitment of in-kind resources to support the United Way of the Capital Region's Money in Your Pocket VITA Campaign for January through April 2026. Market Square will contribute \$9437 in in-kind donations in recognition of the excellent tax preparation services provided to those in our community who need them most.
- **5)** Approved Market Square's participation in an Oral Care Product Recycling program and commended the committee for their efforts.

Outreach and Marketing

6) Approved contracting with Lamar Advertising for a digital billboard on Second Street during Advent at a cost of \$1700 for four weeks. The cost shall be paid using the Heath Allen Mission Fund.

Trustees

7) Authorized the use of up to \$12,000 from the Carl Petersheim Fund to be used for construction of a lower-level office for the Minister of Music.

Membership

8) Recognized the death of the Reverend Lois Richwine, an active attendee of MSPC and a former staff member, who died unexpectedly on Sunday, November 16, 2025.

Congregation

- **9)** Called a congregational meeting for the purpose of electing 2026 officers on Sunday, December 21, 2025 following the 11:00 a.m. worship service.
- **10)** Set the service to ordain and install new officers for Sunday, January 18, 2025.
- 11) Set the annual congregational meeting for the purpose of hearing and acting upon reports from the officers of the corporation, to receive 2025 annual reports, to review the 2026 church budget, and to finalize the terms of call for the Head of Staff/Pastor on Sunday February 1, 2025 immediately following the 11:00 a.m. worship service.

As of November 18, 2025, there were 340 members on the church membership rolls. If you have any questions about Session activities, you may talk with me, a Session member, or one of our Pastors.

Board of Trustees Update

Not only in November but throughout the year, there is much for which we can be thankful at Market Square. These are among the things for which the Trustees are thankful this year:

Completion this Fall of the church's two-year exterior restoration. Not only is the building better protected from the elements, but it also has a crisp, refreshed look that says what we know: MSPC is a vibrant congregation here to stay in fulfillment of its many missions and enduring faith.

Conclusion of the waterlogged lower level's restoration. With a sense of déjà vu for some perhaps, the music department again took up residence there after some years as the children's education suite.

Design and installation of an exterior door on the Blackberry Street alcove to eliminate use of that space for unsafe storage or occupancy by some of that space.

Award of a state grant that substantially funded the Safety & Security Committee's plan to improve exterior safety and security. Unobtrusive cameras have been installed and improved lighting is forthcoming, both to discourage untoward or dangerous activity on the building's perimeter.

Input from the Harrisburg Police in helping the Committee adopt best practices. One such: posting numerals inside and

out on exterior doors to assist timely access by emergency responders to the necessary, specific location within our sprawling building.

And finally, we are thankful for the mostly behind the scenes work of the Budget and Investment Committees. The former takes the "short view" of MSPC's finances through the daunting task, ongoing as this is written, of crafting the annual church budget for Session's consideration.

The "long view" of MSPC's finances is guided by the Investment Committee in concert with financial advisor Bryn Mawr Trust. Additionally, the Committee has taken the lead to encourage members' consideration of legacy bequests through the Beacon Society. Stay tuned for more about this in 2026.

I would like to acknowledge Class of 2025 trustees who will not be serving a further term: Phyllis Mooney and John Dickinson have been particularly active committee chairs; Gwen Lehman has lent her experience, knowledge and insight to many projects; and Michelle Simmons has been indispensable as Secretary Pro Tempore as that need arose. Thank you!

Earth Care Pledge

Hello to each and every one of you. First, I want to thank you from the bottom of my heart. Your presence in our lives means so much to us. Even if I don't know each of you individually, and even if we haven't met face to face, I want you to know that you mean a lot to me, and that your prayers for us are always one of the reasons for our survival and one of the reasons we keep going. Thank you for every word and every moment

Today I am writing to you feeling very down. I wish I could find words to truly express what I'm going through. You may have heard this many times before, but today I mean exactly what I say. I am afraid for my family, for my parents and my children. The situation continues to worsen. Soldiers raid the town every day, carrying out arrests and torture. We stay up every night until morning, vigilant and afraid that they will break into the house and arrest one of us.

Two 16-year-old boys were killed two days ago; they were classmates of my youngest son. He was deeply affected and is now ill. Our spirits are broken. Melissa, my son Zain's 42-day-old daughter, is suffering from a serious liver condition, and her health is deteriorating daily. She is currently in a hospital in Ramallah, but due to the difficult roads, we cannot reach her and check on her. If we decide to take public transportation instead of a car, it will be very expensive. Transportation has become extremely costly, and medications and treatments are very, very expensive. We are having to leave off many basic necessities because of the exorbitant costs.

Fear is consuming me, and helplessness surrounds me. My parents' treatment, household expenses, my granddaughter Melissa, my fear for my children, and the costs of their education and care, I really don't know what to focus on or what to think about. I feel that I will eventually lose all strength and ability.

But, your presence is a source of strength and motivation. Thank you for listening to my words, and I hope that one day I will address you with more positive and joyful words.
